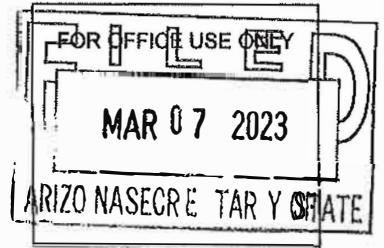

ARS 16-1502 (E) shall be amended to say, "The lists of the candidates of the several parties shall be arranged with the names of the parties in a randomized order commencing with the left-hand column. In the case of political parties that did not have candidates on the ballot in the last general election, such parties shall be randomized below with the parties that did have candidates on the ballot in the last general election. The secretary of state shall select the method of randomization with a technological standard no less than those utilized by the Arizona lottery.

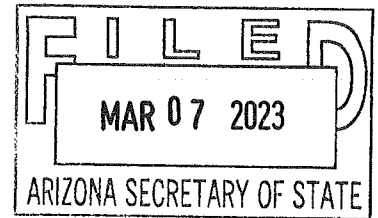

AN INITIATIVE MEASURE

AMENDING SECTION 16-502 (E); ARIZONA REVISED STATUTES; RELATING TO
RANDOMIZATION OF THE ARIZONA BALLOT

Be it enacted by the People of the State of Arizona:

Section 1. Section 16-502 (E), Arizona Revised Statutes, is amended to read:

Section 16-502. Form and contents of ballot

E. The lists of the candidates of the several parties shall be arranged with the names of the parties in ~~descending order according to the votes cast for governor for that county in the most recent general election for the office of governor,~~ A RANDOMIZED order commencing with the left-hand column. In the case of political parties that did not have candidates on the ballot in the last general election, such parties shall be RANDOMIZED ~~listed in alphabetical order below~~ WITH the parties that did have candidates on the ballot in the last general election. THE SECRETARY OF STATE SHALL SELECT THE METHOD OF RANDOMIZATION WITH A TECHNOLOGICAL STANDARD NO LESS THAN THOSE UTILIZED BY THE ARIZONA LOTTERY.
